Ring the Bell, Raise the Hope: Indiana's AEF Impact Grows Stronger!

The Auxiliary Emergency Fund (AEF) is more than a program - it is our heart in action. It is how the American Legion Auxiliary lives out "Service Not Self" when our members face hardship or disaster. And this year, the Department of Indiana stepped up in bold, beautiful, and creative ways to ring the bell of hope louder than ever before.

From tribute trees and coin toss games to license plate drives and bell-themed raffles, our members showed up with energy, compassion, and innovation. Through your efforts, we collected almost \$14,000 with 44 Units giving more than they did the year before. Even more promising: the number of non-contributing Units dropped from 111 to just 90 - a 18% improvement. That's momentum worth celebrating!

This year, we launched the AEF Cardinal Tree Fundraiser, honoring and remembering loved ones through symbolic red cardinals - raising funds and spirits. From Lebanon to Cayuga to Bloomington, these trees became symbols of unity and generosity.

The strength of our program was reflected not only in the dollars raised but in the stories behind them. AEF Chair Janis Sproat of Unit 381 (District 4) created a Tootsie Pop jar and emergency supply raffles - earning \$600 and drawing attention to preparedness. Heidi Steinhiser of Unit 451 (District 3) partnered with American Legion Riders for a high-impact event. In Elberfeld (District 8), Chair Tia Susott-Joyner and Juniors used umbrellas to collect change on a rainy day ...

Stoner and Otey named recipients of **Distinguished Hoosier Award**

Indianapolis, Ind., July 11, 2024 - Indiana Lieutenant Governor Micah Beckwith addressed the American Legion Auxiliary delegation during the opening session of the 104th Annual Department Convention.

While Lt. Governor Beckwith acknowledged The American Legion as a "pillar of strength within our communities, he gave credit where credit is due.

Your role reiterates the fact that even the bravest veterans, service men and women need support. You are a constant reminder that clearly shows everyone needs someone to lean on. Your impact is visible in every community," he said in praise of the Auxiliary's efforts.

He then turned his attention to this year's Auxiliary leadership - Department President Roxanna "Roxy" Stoner and Department Honorary Junior President Grace Otey by awarding them the Distinguished Hoosier Award, one of the highest awards given to Indiana citizens by the governor. "Roxanna Stoner is the president of Wabash Unit 15 in the Fifth District. Her journey began with her father's bravery on Okinawa in World War II and continued through her husband Jerry's service in Vietnam. After 40 years at Ford Meter Box Company, she didn't retire from service - she ramped it up. This year, she has been ringing bells across Indiana to raise donations for the Indiana Veterans' Home and the Dr. Otis Bowen Vets House. Having spent months there caring for her husband, she knows exactly what our veterans need. Her humility, steady leadership, and her compassion set an example for all of

"At age 8, Grace Otey asked for donations instead of birthday presents and began volunteering with Helping Veterans and Families. She has continued this mission throughout her childhood. As this year's honorary Junior President, she chose HVAF for her project. When a fire threatened their work last fall, she didn't slow down – she created poppy art,

spoke at American Legion events across the state and raised more than \$20,000 to support veterans in crisis. Her determination shows that even at age 15, one young person's heart can make a big difference. Thank you for setting a wonderful example for all young Hoosiers.

This Finance Committee started the year meeting at Department Headquarters to compile the 2024-2025 annual budget, mandatory fees, and monetary sheets.

We were thrilled with the response to our Department Sweepstakes and the drawing held at the 2024 Fall Conference. Our members do love to gamble!

Sadly, our membership has dropped again this year, so we can

no longer rely on dues to pay for the Department obligations.

The Finance Committee approved the hiring of our Department Secretary, Marti Drake. Welcome back Marti!

The Indiana Natural Disaster Fund has been established thanks to Past Department President Rose Ann Dzieglowicz. The fund has \$6,000 to be granted to members of the Department of Indiana who have suffered from a natural disaster. Application forms and information will be in the fall packets.

I hope this will be a blessing for some of our members.

After extensive research, the Finance Committee found that we were losing nearly seven cents per poppy made, plus the cost of postage in some instances. We could not keep losing money on poppy production. The new cost for poppies is \$25 per hundred for in-state orders, plus postage if mailed and \$30 per hundred for out-of-state orders, plus postage.

This year, it was time for a new Department vehicle. The Finance Committee and DEC have approved the purchase of a 2025 Chevrolet Traverse with trade-in of the 2022 Kia Sorento.

The Finance Committee and the DEC have approved the establishment of an Indiana Auxiliary Emergency Fund (AEF) with a three-member committee to establish procedures and guidelines. This would mean that your AEF contributions would stay in Indiana instead of being sent to the National Auxiliary.

We have received approval from The American Legion to plant a tree at Department Headquarters in memory of Kathy Knafel, Department Treasurer.

This has been an emotional, challenging, and learning year for this Finance Chair and I thank everyone for your patience and understanding with accounting questions directed to our Department Headquarters staff.

Greetings Auxiliary members, It's hard to believe that we have come to the end of the year. The ALA Legislative program was a great opportunity for members to apply our Department President's theme, "Ringing Bells for our Veterans." Units and Districts shared their legislative activities concerning veteran matters and issues affecting their daily lives and well-being.

At Spring Conference, I was asked to give a presentation on our Legislative program and my trip to the Legislative conference in Washington DC. We reviewed the 2025 American Legion pri-

orities, highlighting a few talking points from each priority. We also had a little visitor. "Mr. Bill" showed up and sang his famous schoolhouse rock song, "I'm Just a Bill." We had a little fun sharing some trivia by handing out crossword and seek & find puzzles regarding state legislation and Indiana fun facts. Participation was outstanding! Some Auxiliary members stated they didn't know they could have such fun in a legislative session.

At the DC Conference, I made two trips to Capitol Hill. On the first day, I traveled to the Hill for our first legislative meeting where we discussed bills and resolutions pertaining to our veterans and the military. It was an awesome feeling to be there representing our Department on behalf of our veterans. Day 2, I traveled to the Hill with our very own Vickie and Jim Koutz and Ron Byrley. We met with Indiana US Representative Mark Messmer to discuss key points related to the American Legion's 2025 legislative priorities. We expressed our concerns over veterans' healthcare benefits and the increasing percentage of female veterans' homelessness and the need for resources to get assistance. He stated his profound respect for our veterans and would do his part to make a difference in their lives. Auxiliary members, please continue to vote for legislators that support and make our veterans a high priority. This is just another way to thank them for their service.

Now, let's look at our Department's legislative accomplishments. Year-end reporting was slightly above 2024 but still needs improvement. Nine of 11 Districts submitted reports which included 84 of 240 Units reporting. It was reported that 2,690 emails were sent to federal, state, and local officials, with 1,766 replies. Letters mailed totaled 105 with 179 replies. The total number of calls was 134 with 60 discussions. Lastly, the total number of visits was 69 with 28 follow-ups.

A total of 3,774 hours was reported for legislative advocacy, volunteering, and supporting the 2025 American Legion priorities. Activities and events included: Town hall meetings, meet the candidates, roundtable discussions, attending state house legislative sessions and hearings, local board meetings, city, county and commissioner meetings, national

congressional meetings with representatives, members signed up using the grassroots action center alerts, volunteering for voting polls, voter education and registration. District 11 (Indianapolis) attended a Senior's Legislation Day at the state capitol building. In attendance were the Indiana Department Commander, District 11 ALA Legislative Chair, Amy Alyea, and other Legion family members. Also in attendance was veteran Margaret Brown. She served in the Air Force during WWII. She also celebrated her 101st birthday on that visit to the state capitol. What a blessing.

The winners for the legislative program were announced at the Department Convention. The Rose Ann Dzieglowicz Monetary Award for the Unit submitting the best narrative for year-round reporting goes to Kokomo Unit 6, District 5, Barb Parkhurst, Chair.

The District with the best yearround legislative program narrative goes to District 11, Amy Alyea Chair.

Congratulations to our winners and a big thank you to all of you for your continued support of our veterans' legislative affairs.

The last objective was 102% and 59 Units qualified. The winners are ALA Unit 161 Mishawaka, District 3 and ALA Unit 35

Jeffersonville, District 8.

From the 93 Units at 100%, we pulled six winners for \$100. The 100% Unit drawing winners are: ALA Unit 20, Crown Point, District 1; ALA Unit 12, Frankfort, District 5; ALA Unit 72, Crawfordsville, District 6; ALA Unit 205, Franklin, District 7; ALA Unit 204, Sellersburg, District 8; and ALA Unit 239, Lawrenceburg, District 9.

The personal award for the best District narrative is District 3, Membership Chair Jan Kowalski. No Units submitted a narrative.

The winner of the Lincoln Gavel is District 1. They were the first District to make 100%.

The Lincoln Pilgrimage winners were: ALA Unit 66 Griffith and ALA Unit 485 Schererville -both from District 1.

Community Service

A lot of bells have been heard this year with the number of good deeds being completed by the American Legion Auxiliary! A total of nine out of 11 Districts reported and these numbers are unmatched!

Did you know that one volunteer hour equals \$33.49 in monetary value?

Our Districts reported a total of 41,276.5 hours served. When multiplying these hours by the amount that one hour is worth, Indiana donated time is valued at \$1,382,349.99! On top of the hours collected, Indiana spent/donated over \$107,812.61 as well as drove around 26,749 miles.

Units have reported celebrating their communities by hosting birthday, Halloween, Christmas, and Easter parties. They raised funds for different local charities such as Granted, Community Angels, Boys and Girls Club (in their town), League of Miracles as well as national charities such as Ronald McDonald's house, and Breast Cancer Awareness, Others hosted drives for women shelters and hurricanes, volunteering with church community programs, donating time at farmers markets, and lent a hand at other local organizations such as the Shriners. In addition, Units reported cleaning up parks and hosting a Family Legion Day.

Awards:

The Carolyn Cunningham Monetary Award for Best Year-Round Community Service: Mooresville Unit 103 from the 7th District.

The Department Award entitled, "Thinking Outside the Box" goes to: District 7, Unit 351.

This year Unit 351 teamed up with a local organization called Community Angels and helped them gather presents for the children in their community. Not only did the Auxiliary help, but they also created a Jeep side by side Fun Run event with their Rider chapter. At the end of the run, the Legion held the final night of the event where the Juniors helped with games and snacks, the Auxiliary held a silent auction, and the Legion Family raised \$1,200 for the organization. In total, the organization raised \$16,000 and served gifts to 45 kids.

Personal Awards:

American Legion Family Day Award: Mooresville Unit 103 of District 7. The family worked together to create a community event with proceeds being split between their local Boys and Girls Club as well as a local 7-year-old who is fighting cancer. They advertised by submitting an article to their local paper and sending and posting flyers throughout their community. During the event, those in attendance had the opportunity to enjoy oversized games, a dunk tank, a bounce house, as well as enjoying some smoked pork butt.

The Unit Member Award is awarded to the Auxiliary member who reported the most hours served. The Unit Member Award goes to: Jone Nicholoff from Unit 241 of the 4th District with a total of 1790.5 hours served.

Education

As the final bell rings and we wrap up our class, The American Legion Auxiliary (ALA) Department of Indiana has gone above and beyond this past year to promote quality education for children. This was the year to - Ring our Bells for Children in Education!

Members gathered at the Indiana Auxiliary Fall Conference to learn and receive instructions about the ALA programs. During the Education presentation, class was in session for what members could do to have a successful Education program and earn an A+.

With tools in hand, the Units and Districts stepped up and started promoting the various elements of the Education program. The Unit and District reports were "chalked" full of exciting and busy activities demonstrating our commitment to the education of children and the future of our nation.

Units reached out to their local school(s) inquiring about specific needs then delivered! Knox Unit 131 found out that a new pre-school had been started so they donated clothing items that were requested for emergency situations. Remington Unit 280 hosted their annual backpack program. They included school supplies, but they also included a birthday bag with a cake mix, frosting, candles, and a birthday card for each student. Cannelton Unit 142 made backpacks, filled them with the items listed on the school supply lists (contributing over \$3,600), and gave them to the students.

Units in the First District reported sending \$17,998.17 to a local grocery store "Apples for Education" to be given to local schools for playground equipment and needed items. Several Units in the First District also donated items and money to purchase items for the "Care Closet" at the middle and high schools for families needing school supplies and hygiene items.

Starting with the ALA's Give 10 to Education, it was reported that 31 Units participated in this program, giving a monetary value of \$11,407.98. Mooresville Unit 103 sponsored a school supply drive with the whole Legion family participating. An ALA member created a collection box that was placed at the Post, along with handouts listing needed items. An announcement about the event was published in the Morgan County Correspondent, sharing

the program and encouraging community participation. Members distributed the collected supplies along with trays of cookies and muffins to the local schools.

Lyons Unit 479 ensured the collected Give 10 to Education supplies matched their schools' needs. Members contacted the schools, explained the program and its purpose. They provided a copy of the suggestion list and suggested that they also identify items needed that were not on the list. With the lists in hand, members shopped and distributed supplies to the local middle schools.

Next, it was reported that 35 Units promoted American Education Week and Teacher Appreciation Week, giving \$5,673.71. Several reported gifting multiple items to their favorite teachers! Unit members delivered school supplies and treats for students and staff at local schools during these weeks.

Food is always a nice treat for our educators. Lyons Unit 479 members prepared and delivered trays of muffins, fruit and cheese to local schools for American Education Week. Hamilton Unit 467 prepared and served lunch for the staff at their local school during Teacher Appreciation week then presented a small gift to each teacher to show them some love. During American Education Week, Mooresville Unit 103 delivered approximately \$190 worth of needed school supplies and popsicles for the children of two local schools. Cannelton Unit 142 delivered donuts to their local schools during American Educa-

Gift cards were handed out during these two weeks as well. For American Education Week, a restaurant donated a \$50 gift certificate that the Lafayette Unit 11 delivered to an elementary school for a drawing held during one of their staff meetings. Then for Teacher Appreciation Week they delivered two \$25 gift cards to Barnes & Noble to be drawn during a staff meeting.

Indiana Units adopted classrooms and schools this past year. Eleven Units reported adopting a classroom or school and contributed \$5,560.29. Units set up trees and decorated throughout the different holidays. These trees were set up like an angel tree where members could take a listed item needed by the school or classroom, purchase that item, then bring back to the Post to be donated to the classroom or school.

Lafayette Unit 11 adopted a school this year and they worked to enhance their little library by providing subscriptions to the Ranger Rick magazine.

Hymera Unit 298 participated in the Adopt a Classroom/School program. Members donated totes of necessary supplies to each class, including physical education, as well as funds to support field trips, ensuring that the teachers did not have to pay out of their pocket!

While ringing bells for our Veterans, eight Units reported

participation in the Veterans in Community Schools, giving \$1,096.43. Syracuse Unit 223 sponsored a Veterans in the Classroom on Veterans Day. She is the Post Commander and a dual member.

Next, it was reported that 41 Units presented/awarded 105 scholarships, totaling \$58,800. Units also reported donating \$4,813.45 for the Department scholarships. The price is always right, when students apply for a scholarship with the American Legion Family! A promotional brochure was developed this past year to share with members and was leveraged on social media.

A new Facebook Group for the Indiana ALA Education Program was implemented this past year. This social media platform was leveraged to communicate with members more broadly and provide ideas to utilize throughout the year. In addition to the new Facebook Group, an Educator of the Year Award was promoted.

As one can see, Indiana was busy with educational activities this year volunteering approximately 729 hours and donating over \$87,000 to the various education initiatives. It is a difficult task to mention all the activities, hours, funds, and smiles that the Department of Indiana has endured during the Education class this year, but the bell has rung, and class is now dismissed.

On Sunday, June 22, 2025, on the beautiful campus of Trine University in Angola, Indiana, 275 excited, yet scared, young women registered for a week-long program that would forever change their lives. In 2024, if you recall, there were two delegates that were so determined to attend our program that when their car broke down on I-69, they called a tow truck to bring them the rest of the way. This year, we had a delegate that wanted to attend so bad that she hired an Uber driver to take her from Lebanon, Indiana all the way to Angola, Indiana!

On Monday, June 23, 2025, we were honored to have several of The American Legion dignitaries join us including Commander Robert (Rob) Burkhart. Our special guest speaker for the evening was, Major Jonathan Turnbull. Major Turnball, US Army Retired was given a zero percent chance of living beyond 24 hours after suffering devastating injuries from an ISIS suicide bomber attack on January 16, 2019, while on a special mission in Syria. He suffered extensive head trauma and is totally blind, but he has lived to defeat all odds. Although he walks with minimal pain, his mind is fine. Currently Major Turnbull continues to train, mentor, and inspire others through speaking engagements. He and his wife, Samantha, are the authors of the book, Zero Percent Chance, and a children's book, A Detroit Tigers Hat from the Ballpark to the Battlefield. Major Turnbull and his family reside in Michigan where

What does Americanism look like in action? For the American Legion Auxiliary, it looks like flags, parades, patriotic essays, and thousands of hours spent teaching our youth and serving our communities - all wrapped in red, white, and blue. This year, members across our organization proved once again that Americanism isn't just a concept we talk about during patriotic holidays -

it's something we live every day.

Patriotism with Purpose - Let's start with the numbers, because they speak volumes:

- 1,634 hours were volunteered in direct support of youth-centered Americanism efforts.
- We spent \$14,971.53 on activities designed to educate and inspire the next generation
- An additional \$21,664.82 in direct aid was provided to support children in need.
- Over 7,127 children were reached and impacted by our programs.
- We gave \$7,875.00 to other child-focused service organizations, because our mission doesn't stop at our own programs.

Our members taught lessons in patriotism that extended far beyond the classroom. We guided students in flag-folding ceremonies, supported Americanism essay contests (with 14 submis-

sions!), and handed out over 150 American flag comic books - because who says learning about the flag can't be fun? Some Units sold American flag scarves to raise money for purchasing actual flags to distribute in their communities. Others donated flags to schools and memorials - including Lyons Unit 479, which provided an American, Indiana, and POW/MIA flag for the Newberry, Indiana Veterans Memorial. At local libraries, the spirit of patriotism was front and center. A growing community program in North Webster brought in over 400 attendees and provided patriotic books and bookmarks for circulation. And in schools across the state, we brought coloring contests, flag education, and a love of country into the hearts of our youngest citizens.

Building Traditions & Teaching Respect

In schools, libraries, parades, and cemeteries, our Auxiliary members showed up to ensure

America's legacy is honored and remembered. We hosted flag disposal ceremonies with local Scout troops, taught etiquette to youth organizations like the Boys and Girls Club, and brought "Betsy Ross" to life for curious kids. We passed out flags, pins, pencils, and bracelets at community festivals, making patriotism tangible and exciting. Our members stood tall with honor guards at funerals and remembrance events, led Memorial Day parades complete with golf cart decorations and balloon releases, and participated in Wreaths Across America - placing more than 150 wreaths at cemeteries to honor those who served. And when the holidays arrived, we kept the flame of Americanism burning - literally. At the annual tree lighting in Avilla, we served cookies to children waiting to see Santa. Our coloring contest winners were even the first in line to sit on his lap! We honored our military families by encouraging

local children to wear purple on Military Kids Day, and we proudly wore red on Fridays for "Remember Everyone Deployed." We also packed care packages for active military members and supported Honor Flights and Quilts of Valor presentations - because service doesn't end at the battlefield.

Investing in Our Communities

Our Americanism work went hand-in-hand with service to our communities. Auxiliary members reported a staggering 13,590.5 community service hours, and we invested \$91,407.40 in projects that made a difference in the lives of neighbors, veterans, and families alike. Our events ranged from Trick or Trunk celebrations and holiday food drives to patriotic "Patriotic Pops" concerts and participation in local festivals. We showed up with enthusiasm, snacks, and (sometimes) glitterbecause nothing draws a crowd

History

As the year started, like many of you, I had goals and plans on what I wanted to do this year. Things don't always go as we plan but Winston Churchill gives me encouragement with his famous quote, "Success is not final, failure is not fatal: It is courage to continue that counts." Courage to

continue we have; and we always prevail. We learn as we go and documenting success and failures along the way is so important. While I worked on getting my things together for the year-end, I didn't see many failures. I know we had them and we discussed them, but they aren't getting documented to share with our future leaders. Perhaps we can work on that; help those who come after us by sharing what we could have done to make things better.

I was excited to help National President Trish Ward with her project of collecting charters with every National President's signature on it. Thank you to those who took the time to send me a picture of your charter. District 11 won my contest with the highest percentage turned in with District 7 close behind.

March was awesome thanks to all those who helped highlight Hoosier ladies making a difference in history. We covered every day and shared some amazing facts that I didn't know, even information about Elberfield Unit 351. I received information from

the National Archivist about how we need to preserve our documents better. First, if your document is touching the glass, it could damage it by sticking to the glass. We need to make sure we keep these items dry, away from moisture, flat and out of direct light. It is recommended they be removed from the frames, if possible, digitized and stored away in a place where no light reaches them. They should be digitized at 600 dpi TIFF for preservation purposes and at 300 dpi jpeg. A print can be made from the jpeg and placed in a frame instead. Make sure that you and your Unit make the decision for your documents wisely. This brings us to another history item, the beautiful shiny vintage jewelry. Each item has a history and meaning. Whether it be the pin your mentor wore or the charter your ancestors signed. Katie Jasionowski has taught me a lot about the wonderful pieces that those before us wore. She is a wealth of knowledge and willing to share with you what she knows.

Now on to the winners of History awards for the year. First, I

want to thank those who took the time to enter History Books. You are all winners for your time and effort passed on to the next generations. The Louise Loyd Monetary Award to the Best District History Book goes to District 10, Wanda Cooley. Thank you for your great book and also to District 9 Historian Judy Cox for your first entry. Looking forward to seeing next year's book. Cherril Threte Monetary Award to the Best Junior Unit History goes to Junior Honorary Department Historian Ellie DuPont from 8th District. My personal awards for Best Unit History books: Second place goes to District 7, Unit 479, Historian Julie Baker; and my first-place winner goes to District 6, Unit 113, Historian Tess Hogston. Always remember to first refer to your Constitution & Bylaws to answer questions and if the answer is not found there, refer to Robert's Rules of Order Newly Revised. Also, any changes to the National Constitution & Bylaws made by National automatically replace the Unit, District, and Department Constitution & Bylaws. A vote does not need to be held for these changes.

The Sally Wilhelm Monetary Award for the best year-round Constitution & Bylaws program is Fourth District, Diana West, District Chair. Congratulations!

Please continue to update your Constitution & Bylaws. It is the road map of our organization and important to our Units, Districts and Department running smoothly and consistently.

Risk & Compliance

This year has been a learning experience for most of us as we navigated through the Federal Regulations as they apply to a non-profit 501(c)(19) veteran's organization as well as the American Legion Auxiliary guidance and governing documents. We have established a relationship with the National Headquarters team which has enabled us to foster a culture of transparency and proactive vigilance in regard to our Department Auxiliary Risk & Compliance business health activities. Throughout the year. we have worked closely with multiple District and Unit officers and chairs to ensure compliance with state and national guidelines. We have offered guidance, support, and resources to empower every Unit member who requested assistance in helping their organization become compliant with State and Federal regulations. We promoted best practices and continuous education in risk management with our aim to safeguard the

well-being of members and upholding the organization's commitment to integrity.

We provided assistance and recommended resolutions to Units in six (6) of our eleven Districts. This included actions pertaining to gaming license, authority of the Post Commander with the Auxiliary Unit, Fidelity Bond coverage, and responses to IRS notifications.

We coordinated with National Headquarters and implemented their supplemental instruction to the Internal Revenue Service (IRS) Form 1024 Application for Recognition of Exemption Under Section 501(a) or Section 521 of the Internal Revenue Code. This supplemental instruc-tion is titled, "American Legion Auxiliary National Organization SUPPLEMENTAL INSTRUC-TIONS - FORM 1024 TO SEEK REINSTATEMENT OF REC-OGNITION AS A 501(C)(19) VETERANS' ORGANIZATION (UNITS, DISTRICTS, COUN-TIES OR COUNCILS) "To Seek Reinstatement of Recognition as 501(c)(19) Veterans' Organization (Units, Districts, Counties Or Councils)." We have created a standardized financial table to assist Units and Districts in compiling their required financial information for the 1024 form.

As we adapt to these evolving standards, collaboration, and open communication will be central to our approach. Looking ahead, we are hopeful that we can establish critical training, workshops, and seminars designed to clarify compliance issues, for

Department, District and Unit officers and committee members, while sharing best practices and resources with one another. This collaboration will strengthen our understanding of key requirements, ensure greater organizational transparency, and equip us to better serve our American Legion and Auxiliary programs. Looking ahead, we remain committed to ongoing education and vigilance, recognizing that strong compliance not only protects our organization but also underpins the trust our organization places

As we reflect on our accomplishments and challenges, it becomes clear that sustained progress relies on the curiosity and engagement of every member. Ensuring participation in compliance training and the annual reporting process continues to grow, demonstrating a collective commitment to excellence, and accountability.

Moving forward, we will focus on further strengthening the network of support among Districts and Units. By leveraging the expertise developed this year, we intend to introduce peer mentorship opportunities, where experienced members can guide those who are new to navigating compliance tasks. This spirit of collaboration will not only ease the learning curve but also foster a sense of unity and shared purpose across all levels of our organization.

Additionally, we are exploring the integration of digital tools and resources to streamline documentation and reporting procedures. Developing user-friendly checklists, online tutorials, and regular Q&A sessions will empower members to feel confident in managing compliance requirements independently, while still having access to guidance when needed.

Our vision for the coming year is ambitious but achievable—with continued dedication, open communication, and the willingness to adapt, we can make compliance an accessible and rewarding aspect of our mission. Together, we will uphold the highest standards of integrity, ensuring that the Department of Indiana continues to earn the trust and respect of its members and the communities we serve.

Veterans Update

Veterans Affairs & Rehabilitation

The American Legion Auxiliary Department of Indiana is proud to 'Lead the Way' by supporting our veterans through the VA&R program. We started the year on a sad note when VA&R Chair Sandy McCool passed away. Sandy was a dedicated member of the ALA and actively supported our veterans.

The year began by having a Veterans Shower at the Department Fall Conference where \$4,532.00 was raised for our hospitalized veterans. The Department VA&R Chair asked for volunteers to take donations, and the ladies stepped up in a big way.

HVAF is a homeless veteran's facility in Indianapolis. There was a massive fire at HVAF last fall. The ALA donated money, food, hygiene products, and clothing to the displaced veterans. The Units took collections to help restock

the food pantry.

The Department VA&R Chair attended Christmas Gift Wraps at the Danville VA, Marion VA, and Indiana Veterans' Home. The Units donated items for the veterans at these hospitals. The gift wrap at Marion VA is a little different. Gifts are also picked out by the patients for their family members; volunteers wrap the gifts, and the gifts are placed in mailing boxes and mailed to the family members. Due to bad weather, the department chair was unable to attend the Richmond VA gift wrap but attended the quarterly birthday party. The veterans appreciate all the ALA does for them.

The Units reported volunteering for the Honor Flights throughout Indiana. Thank you cards, snacks, and Welcome Home celebrations are some of the activities reported for the Honor Flight. Many Units donate money to the guardian to go on the flight with the veteran.

Some of the activities reported by Units were: Donations to Camp Carson; Veterans Day Program; helping a veteran's family dealing with the loss of a family member by providing support in the sorting and removal of items from the home; cleaning and assistance with funeral arrangements; flag placement at the cemeteries for Memorial Day; supporting Blue Star Mothers; National Legacy Run; Tunnel to Towers; Operation Comfort Warriors; providing meals and childcare for military children; Veteran's baby shower; Camp Read A Lot; I Can Volunteer; National Guard send-off; welcome home events; providing Christmas to needy veteran families; donating Buddy Bags; setting up information tables at County Stand Downs; and sending care packages. One Unit provides the County Service Office with gift cards in \$25 to \$50 increments to give to veterans who come to the VSO for help. The cards are to be used for food and gas that is so necessary when applying for jobs: the same Unit donated money to a War Dogs Chapter 3 dog handler to help with food and medical expenses for the retired dog he adopted.

Many Units sponsor Wreaths Across America. The veterans in Camp Atterbury Prison Post also help with the wreaths.

We, currently, have a census of approximately 120 residents that includes: Five female veterans, 52 Army, 17 Navy, 16 Marine, 22 Air Force, and one National Guard; Ten female spouses, and one married couple.

Everyone has two or more sponsoring Units, and most of you are doing very well sending cards, gifts, or money to your residents. You also sent money, treats, and hygiene items as well as puzzles books for the goodie cart (which we offered to the residents for free). Some of you sent baseball-style caps with military insignias on them. Boy, did they like getting those! They were a big hit. She made my job go a lot easier due to her energy and enthusiasm. A big thank you goes to the 2nd District IVH Chair Bonnie West. She volunteered many days with the goodie cart. I also want to give a big thank you to my other District Chairs. This is not a "gravy" job. It is hard work trying to keep everyone sponsored and happy. They all did a good job relaying messages for me.

Poppy

The Department of Indiana was busy Ringing our Bells for our veterans and working the poppy program this past year. I received ten reports, representing 101 Units. Units reported 55,670 poppies ordered, which was an increase of 6,400 poppies over last year. In total, 57,620 poppies and 3,138 poppy items were distributed. Through these activities, \$107,696.41 was raised and \$73,437.19 of that was used to help over 1,688 veterans and their families. Units also reported 3,903 hours volunteered and 2,981 miles driven. Just imagine what those numbers would be if every Unit reported!

How did Units promote the poppy? Almost every Unit reported handing out poppies on or around Poppy Day! Several Units were able to get the mayor to proclaim May 23rd Poppy Day. One

Unit reported being on the radio and talking about the meaning of the poppy. Members used the newspaper, local news and your own newsletters to get the word out. Lots of Units utilized social media too. In addition to that, you placed donation cans in your canteens and in businesses in your communities. You participated in parades and festivals and distributed your poppies and poppy items. You placed wreaths and decorations around town as well as in your Post homes. You wore poppies and poppy items daily. One Unit held a Poppy Dance! Juniors got involved with all these activities too. One Junior told the poppy story to her class and handed out poppies to fellow students. Several Units mentioned other school events where the poppy was the focus including reading, The Poppy Lady to an elementary class. Members were determined to get the poppy out there and educate communities about the poppy and what it means!

What types of poppy items were distributed? There were corsages for all kinds of events along with boutonnieres, centerpieces, bouquets and other decorations. Some Units made items; others purchased them. There were poppy keychains, bags, bookmarks, coloring books, hot pads, snap pouches, seeds, hats, pins, pins with ribbons, plates, canisters, stickers, wreaths, cookies, poppy wrapped suckers, crocheted pop-

pies and can covers, the history of the poppy, and copies of, "In Flanders Field."

How did Units use the \$73,437.19? A lot of Units reported using their poppy money for HVAF and helping them after the devastating fire. Creative Arts was another program that many Units supported with their poppy funds. The Honor Flight Network was another big recipient of our Indiana poppy funds. In fact, the poppy can contest at Spring Conference brought in over \$6,100 for the Honor Flight Network! Units also donated to VA Food Banks to help the military families they serve. Several Units reported using their money to support their VAMC and help with a VAMC baby shower. Some other uses of your poppy funds were helping a veteran with medical expenses, veteran support packages, food for a veteran in need, homeless veterans, veterans on hospice, and many more. Several of the uses reported do not really qualify for poppy fund use, so I urge you to read your rules and stay vigilant.

Now for the contests and awards. I am pleased to announce that we have an Indiana Little Miss Poppy this year! She is a young lady who is very involved with the Juniors, the Auxiliary, the Legion Post, her school, her church, and her community. In

proving that even a drizzle can water the seeds of service.
